#### What we do as Governors

We have a strategic role within the school, which means that we are not involved in the day-to-day management of the school, which is the responsibility of the Headteacher and her staff. We are expected to play the part of a 'critical friend'. This means striking the right balance between challenge and support. In this role we question and suggest refinements to the proposals and policies of the school. We are involved in appointing staff and dealing with any matters which could involve appeals and we are responsible for the School Budget. We keep abreast of current developments in education through the Derbyshire County Council and Diocesan governor training briefings. We have also completed a skills audit within the Governing Body and ensured that Governors are allocated to appropriate committees.

The governor with responsibility for Safeguarding regularly reviewed safeguarding issues in the school and discussed them with the Headteacher.

Following the retirement of Mrs Heidi Elks as Headteacher, at the end of 2023, Governors were very pleased to appoint Mrs Davinia Gamble as our new Headteacher.

As part of the school inspection by Ofsted, governors met with the inspectors in October 2023.

The parents' questionnaire has been reviewed, with very positive results, showing children feel safe and enjoy being at school. As a result of the responses, additional clubs have been arranged to run after school, options for online spelling practise are being considered and plans have been made for additional signage.

Attendance has been monitored and the new national guidance and rules have been implemented.

The Resources Committee has set the school budget and monitored projected pupil numbers.

We have been involved in the setting of the School Improvement Plan, which focuses on the further development of good teaching in the school, increasing the level of challenge for the more able in lessons and reviewing the effectiveness of the new 'Sounds Write' phonics scheme.

Governors have monitored projected pupil numbers and have been involved in a range of marketing initiatives, for example the Forest School Open Morning and setting up of our Instagram and Facebook profiles.

All committees have read and approved a wide range of school policies.
